7 **A Resolution confirming an award by the Board of Control of a purchase contract with**  
8 **Graphic Enterprises Office Solutions, Inc., at State Term pricing, for maintenance, service,**  
9 **parts, equipment, and related supplies for all copy machines and eCopy scanner units, in a**  
10 **total amount not to exceed \$54,577.94, for the period of 11/1/18 to 10/31/19, for the**  
11 **Executive's Department of Job and Family Services, and declaring an emergency.**

13 WHEREAS, the Board of Control, at its meeting held October 24, 2018, awarded a  
14 purchase contract with Graphic Enterprises Office Solutions, Inc., at State Term pricing, for  
15 maintenance, service, parts, equipment, and related supplies for all copy machines and eCopy  
16 scanner units, in a total amount not to exceed \$54,577.94, for the period of 11/1/18 to 10/31/19,  
17 subject to confirmation by County Council; and

19 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
20 that the aforementioned purchase contract with Graphic Enterprises Office Solutions, Inc., is  
21 necessary and in the best interest of the County of Summit;

23 NOW THEREFORE, BE IT RESOLVED, by the Council of the County of Summit, State

28 The award by the Board of Control of a purchase contract with Graphic Enterprises  
29 Office Solutions, Inc., at State Term pricing, for maintenance, service, parts, equipment, and  
30 related supplies for all copy machines and eCopy scanner units, in a total amount not to exceed  
31 \$54,577.94, for the period of 11/1/18 to 10/31/19, is hereby confirmed, and the County  
32 Executive is hereby authorized to execute such purchase contract and any necessary related  
33 documents.

37 This Resolution is hereby declared an emergency in the interest of the health, safety and  
38 welfare of the residents of the County of Summit, and for the further reason to immediately  
39 provide for necessary maintenance, service, equipment, and related supplies.

44 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
45 effect and be in force at the earliest time provided by law.
