7 **A Resolution authorizing the County Executive to enter into agreements for the acquisition**
8 **of standard highway easements at 660 and 665 Medina Line Road, located in Bath**
9 **Township, Council District 5, in a total amount not to exceed \$ \$6,030.00, as part of the**
10 **Medina Line Road Bridge over a branch of Yellow Creek Replacement Project for the**
11 **Engineer, and declaring an emergency.**

13 WHEREAS, there is a public need to replace the Medina Line Road Bridge over a branch
14 of Yellow Creek, and the County intends to undertake the Medina Line Road Bridge over a
15 branch of Yellow Creek Replacement Project, located in Bath Township, Council District 5 (the
16 “Project”); and

17
18 WHEREAS, certain land must be acquired by the County to be utilized as public right-of-
19 way as part of the Project; and

20
21 WHEREAS, acquisition of lands for public right-of-way for the Project is considered a
22 local cost, which must be borne in whole by the local public agency performing the Project, in
23 this case being the County of Summit and the County of Medina; and

25 WHEREAS, the County has negotiated terms for agreements for the acquisition of
26 standard highway easements at 660 and 665 Medina Line Road in Bath Township, Council
27 District 5 to serve as the necessary public right-of-way for the Project; and

29 WHEREAS, this Council has determined, after reviewing all pertinent information, that it
30 is necessary and in the best interest of the County of Summit to authorize the County Executive
31 to execute the aforementioned agreements for the acquisition of standard highway easements;

33 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
34 of Ohio, that;

38 The County Executive is hereby authorized to execute agreements for the acquisition of
39 standard highway easements at 660 and 665 Medina Line Road, in Bath Township, Council
40 District 5, in a total amount not to exceed \$6,030.00, as part of the Medina Line Road Bridge
41 over a branch of Yellow Creek Replacement Project, with the owners of said property, and in the
42 amounts as follows:




