7 **A Resolution confirming an award by the Board of Control of a professional service**
8 **contract with Children’s Hospital Medical Center of Akron, Division of Adolescent**
9 **Medicine, for physician and medical services in the Summit County Juvenile Detention**
10 **Center, for a total amount not to exceed \$242,667.00, for a term from 1/1/19 through**
11 **12/31/19, for the Court of Common Pleas – Juvenile Division, and declaring an emergency.**

13 WHEREAS, the Board of Control, at its meeting held November 14, 2018, awarded a
14 professional service contract with Children’s Hospital Medical Center of Akron, Division of
15 Adolescent Medicine for physician and medical services in the Summit County Juvenile
16 Detention Center, in an amount not to exceed \$242,667.00, for a term from 1/1/19 through
17 12/31/19, subject to confirmation by County Council; and

19 WHEREAS, pursuant to section 177.08(a) of the Codified Ordinances of the County of
20 Summit, contracts for professional services with a physician are exempt from competitive
21 bidding; and

23 WHEREAS, County Council finds and determines, after reviewing all pertinent
24 information, that the aforementioned professional service contract with Children’s Hospital
25 Medical Center of Akron, Division of Adolescent Medicine is necessary and in the best interest
26 of the County of Summit;

28 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
29 of Ohio, that:

33 The award by the Board of Control of a professional service contract with Children’s
34 Hospital Medical Center of Akron, Division of Adolescent Medicine for physician and medical
35 services for the Summit County Juvenile Detention Center, for a total amount not to exceed
36 \$242,667.00, for a term from 1/1/19 through 12/31/19, is hereby confirmed and the County
37 Executive is hereby authorized to execute such professional service contract.

41 This Resolution is hereby declared an emergency in the interest of the health, safety and
42 welfare of the residents of the County of Summit, and for the further purpose of timely obtaining
43 the physician and medical services for the Summit County Juvenile Detention Center.

47 Provided this Resolution receives the affirmative vote of eight members, it shall take
48 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
49 effect and be in force at the earliest time provided by law.
