8 **contract with United Labor Agency to serve as a subcontractor for employment specialist**
9 **and business services to engage youth in the Wage Pathways pilot program and to market**

11 **exceed \$99,211.55, for the Executive's Department of Job and Family Services, and**
12 **declaring an emergency.**

14 WHEREAS, the Board of Control, at its meeting held November 14, 2018, awarded a
15 professional services contract with United Labor Agency to serve as a subcontractor for
16 employment specialist and business services to engage youth in the Wage Pathways pilot
17 program and to market the program to employers, for the period of 9/1/18 through 8/31/19, in an
18 amount not to exceed \$99,211.55; and

20 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
21 that the aforementioned professional services contract with United Labor Agency is necessary
22 and in the best interest of the County of Summit;

29 The award by the Board of Control of a professional services contract with United Labor
30 Agency to serve as a subcontractor for employment specialist and business services to engage
31 youth in the Wage Pathways pilot program and to market the program to employers, for the
32 period of 9/1/18 through 8/31/19, in an amount not to exceed \$99,211.55, is hereby confirmed,
33 and the County Executive is authorized to execute said professional services contract.

37 This Resolution is hereby declared an emergency in the interest of the health, safety and
38 welfare of the residents of the County of Summit, and for the further reason that the
39 aforementioned professional services contract with United Labor Agency is immediately
40 necessary to provide the aforementioned services effective 9/1/18.

44 Provided this Resolution receives the affirmative vote of eight members, it shall take
45 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
46 effect and be in force at the earliest time provided by law.
