14 pay increase under Section 169.07 of the Codified Ordinances of the County of Summit, County
15 Council's approval is required; and

17 WHEREAS, the Director of the Department of Human Resources will review the
18 personnel action for the aforementioned salary adjustment as required by Section 169.07(b) of
19 the Codified Ordinances of the County of Summit; and

21 WHEREAS, the salary adjustment will be submitted to the Director of the Department of
22 Finance and Budget for the certification of availability of appropriated funds, as required by
23 Section 169.07(b) of the Codified Ordinances of the County of Summit; and

26 the aforementioned salary adjustment is necessary and in the best interest of the County of
27 Summit;
