7 **A Resolution confirming an award by the Board of Control of a renewal (first of two) of a**  
8 **professional service contract with Quality Control Inspections, for construction inspection**  
9 **services, for a one-year term, from 1/1/19 through 12/31/19, in an amount not to exceed**  
10 **\$90,000.00, for the Engineer, and declaring an emergency.**

12 WHEREAS, the Board of Control, at its meeting held November 21, 2018, awarded a  
13 renewal (first of two) of a professional service contract with Quality Control Inspections, for  
14 construction inspection services, for a one-year term, from 1/1/19 through 12/31/19, in an  
15 amount not to exceed \$90,000.00; and

17 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
18 that the aforementioned professional service contract with Quality Control Inspections is  
19 necessary and in the best interest of the County of Summit;

21 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
22 of Ohio, that:

24 SECTION 1

26 The award by the Board of Control of a renewal (first of two) of a professional service  
27 contract with Quality Control Inspections, for the construction inspection services, for a one-year  
28 term, from 1/1/19 through 12/31/19, in an amount not to exceed \$90,000.00, is hereby confirmed  
29 and the County Executive is hereby authorized to execute such professional service contract.

31 SECTION 2

33 This Resolution is hereby declared an emergency in the interest of the health, safety and  
34 welfare of the residents of the County of Summit, and for the further reason to immediately  
35 approve the aforementioned professional service contract with Quality Control Inspections, so  
36 that necessary construction inspection services may continue.

38 SECTION 3

40 Provided this Resolution receives the affirmative vote of eight members, it shall take  
41 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
42 effect and be in force at the earliest time provided by law.

46 It is found and determined that all formal actions of this Council concerning and relating  
47 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all  
48 deliberations of this Council and of any of its committees that resulted in such formal action,  
49 were in meetings open to the public, in compliance with all legal requirements, including Section  
50 121.22 of the Ohio Revised Code.


