7 **A Resolution authorizing the County Executive to submit a proposal to the Ohio**  
8 **Development Services Agency, Office of Community Assistance, for the provision by the**  
9 **County of home weatherization services to the portion of Summit County that was**  
10 **previously provided with said services by the East Akron Neighborhood Development**  
11 **Corporation, for the period of 7/1/19 through 6/30/20, for the Executive's Department of**  
12 **Community and Economic Development, and declaring an emergency.**

13  
14 WHEREAS, the East Akron Development Corporation, which provided home  
15 weatherization services to a portion of Summit County (the "Territory"), voluntarily returned  
16 said Territory to the State of Ohio; and

17  
18 WHEREAS, due to said return of the Territory, the Ohio Development Services Agency,  
19 Office of Community Assistance will be accepting proposals for the provision of home  
20 weatherization services to the Territory, for the period of 7/1/19 through 6/30/20; and

21  
22 WHEREAS, the County wishes to submit a proposal to the Ohio Development Services  
23 Agency, Office of Community Assistance for the County to provide home weatherization  
24 services to the Territory; and

26 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
27 that it is necessary and in the best interest of the County of Summit to authorize the County  
28 Executive to submit a proposal to the Ohio Development Services Agency, Office of Community  
29 Assistance for the County to provide home weatherization services to the Territory, for the  
30 period 7/1/19 through 6/30/20;

32 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
33 of Ohio, that:

37 The County Executive is hereby authorized to submit a proposal to the Ohio  
38 Development Services Agency, Office of Community Assistance, for the provision by the  
39 County of home weatherization services to the portion of Summit County that was previously  
40 provided with said services by the East Akron Neighborhood Development Corporation, for the  
41 period of 7/1/19 through 6/30/20.

43 SECTION 2

45 This Resolution is hereby declared an emergency in the interest of the health, safety and  
46 welfare of the residents of the County of Summit, and for the further reason to immediately  
47 authorize the County to submit a timely proposal for the County to provide home weatherization  
48 services to the portion of Summit County that was previously provided with said services by the  
49 East Akron Development Corporation.

16 121.22 of the Ohio Revised Code.


