7 **A Resolution authorizing the County Executive's Department of Job and Family**
8 **Services to make expenditures, in an amount not to exceed \$15,000.00, for hospitality**
9 **items incurred in providing training sessions to be held in 2019, and to provide meals**
10 **for the 2019 Summer Youth Employment Program participants, for the Executive's**
11 **Department of Job and Family Services, and declaring an emergency.**

13 WHEREAS, the County Executive's Department of Job and Family Services
14 ("DJFS") conducts training, including worksite conferences, for the County of Summit;
15 and

16
17 WHEREAS, such training sessions are attended by County employees, outside
18 organization and elected officials; and

19
20 WHEREAS, DJFS also provides meals for the participants of the Summer Youth
21 Employment Program ("SYEP"); and

22
23 WHEREAS, the Executive's Department of Job and Family Services wishes to
24 pay hospitality expenses in an amount not to exceed \$15,000.00, in 2019 related to the
25 aforementioned training sessions and SYEP participant meals; and

27 WHEREAS, the Office of the Attorney General of the State of Ohio issued
28 Opinion No. 82-006, which authorizes the expenditure of funds by a local political
29 subdivision for its employees as long as those expenditures are necessary to further a
30 public purpose and if the political subdivision's determination to make such expenditures
31 is not manifestly arbitrary or unreasonable; and

33 WHEREAS, Sections 177.24 (b) and (c) of the Codified Ordinances of the County
34 of Summit require the approval of County Council for hospitality expenditures exceeding
35 \$2,000.00 per year and for hospitality expenditures for purposes other than employee
36 training, meetings, and organization strategic planning meetings; and

38 WHEREAS, this Council finds and determines, after reviewing all pertinent
39 information that it is necessary and in the best interest of the County of Summit to
40 authorize the Executive's Department of Job and Family Services to make expenditures in
41 an amount not to exceed \$15,000.00, for hospitality items incurred in providing training
42 sessions to be held in 2019, and to provide meals for the 2019 SYEP participants, and that
43 such expenditures are for a valid public purpose;

SECTION 1

The County Executive's Department of Job and Family Services is hereby authorized to make expenditures, in an amount not to exceed \$15,000.00, for hospitality items incurred in providing training sessions to be held in 2019, and to provide meals for the 2019 SYEP participants. County Council hereby finds and determines that such expenditures are for a valid public purpose.

SECTION 2

This Resolution is hereby declared an emergency in the interest of the health, safety, and welfare of the residents of the County of Summit and for the further reason of immediately authorizing the Executive's Department of Job and Family Services to make expenditures for hospitality items incurred in providing training sessions to be held in 2019, and to provide meals for the 2019 SYEP participants.

SECTION 3

Provided this Resolution receives the affirmative vote of eight members, it shall take effect immediately upon its adoption and approval by the Executive; otherwise, it shall take effect and be in force at the earliest time provided by law.

SECTION 4

It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
