7 **A Resolution authorizing the County Executive or designee, to execute or initiate, through**  
8 **the State of Ohio's County Financial Information System and any other documents**  
9 **necessary for the acceptance by the County Executive's Department of Job and Family**  
10 **Services of inter-county transfers of surplus funds from the Ross and Hardin Counties'**  
11 **Department of Job and Family Services totaling \$175,657.03, and to release surplus County**  
12 **of Summit Department of Job and Family Services funds to those Counties in the amount**  
13 **of \$125,607.00, for the Executive's Department of Job and Family Services, and declaring**  
14 **an emergency.**

15  
16 WHEREAS, Section 5101:9-6-82 of the Ohio Administrative Code authorizes counties to  
17 engage in inter-county transfers of surplus funds allocated to county family services agencies  
18 ("CFSAs") by the Ohio Department of Job and Family Services; and

19  
20 WHEREAS. Section 5101:9-6-82(F) states that when two CFSAs agree to an inter-  
21 county transfer of funding, each CFSA shall complete the inter-county transfer budget request in  
22 the county finance information system ("CFIS"), which shall serve as the agreement between the  
23 county directors involved in the transaction; and

25 WHEREAS, Section 5101:9-6-82(F)(3)(b) provides that a board of county  
26 commissioners may assign authority to another party to serve as designee and therefore, grant  
27 that party authority to submit an inter-county transfer budget request on behalf of the county for  
28 a specific period of time; and

30 WHEREAS, the County of Summit and the Ross County Department of Job and Family  
31 Services ("RCDJFS") wish to enter into an agreement pursuant to Section 5101:9-6-82 pursuant  
32 to which the County Executive's Department of Job and Family Services ("SCDJFS") will  
33 transfer up to \$100,871.00 in FFY18 Title XX Base to RCDJFS in exchange for up to  
34 \$150,921.03 of FFY18 TANF Administrative federal dollars which will fund prior year TANF  
35 expenditures; and

36  
37 WHEREAS, the County of Summit and the County of Hardin Department of Job and  
38 Family Services ("HCDJFS") wish to enter into an agreement pursuant to Section 5101:9-6-82  
39 pursuant to which SCDJFS will transfer up to \$24,736.00 in FFY18 Title XX Base to HCDJFS,  
40 in exchange for up to \$24,736.00 of FFY18 Title XX Transfer federal dollars which will fund  
41 prior year TANF expenditures or be transferred to Summit County Children's Service; and

42  
43 WHEREAS, the County Executive wishes to designate the Chief Financial Officer  
44 ("CFO") in the Department of Job and Family Services ("SCDJFS") as her designee to execute  
45 or initiate the aforementioned transfers through the CFIS, and any other documents necessary  
46 pursuant to Section 5101:9-6-82, for both the acceptance and the release by the SCDJFS of the  
47 aforementioned transfers; and

4 WHEREAS, the County Executive desires to obtain the authority of this Council for the  
5 County Executive, or the CFO as her designee, to execute or initiate, through CFIS and any other  
6 documents necessary, the aforementioned transfers; and

8 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
9 that it is necessary and in the best interest of the County of Summit to authorize the County  
10 Executive or the CFO as her designee, to execute or initiate, through CFIS and any other  
11 documents necessary, the aforementioned transfers.  
12

13 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
14 of Ohio, that:

16 SECTION 1

17  
18 The County Executive, or the County Executive's designee as set forth in Section 2 of  
19 this Resolution, is hereby authorized to execute or initiate, through the State of Ohio's County  
20 Financial Information System and any other documents necessary, for the acceptance by the  
21 County Executive's Department of Job and Family Services of inter-county transfers of surplus  
22 funds from the Ross County Department of Job and Family Services ("RCDJFS") of  
23 \$150,921.03 of FFY18 TANF Administrative federal dollars and the Hardin County Department  
24 of Job and Family Services ("HCDJFS") of up to \$24,736.00 of FFY18 Title XX Transfer  
25 federal dollars, and to release surplus County of Summit funds up to \$100,871.00 in FFY18 Title  
26 XX Base to RCDJFS and up to \$24,736.00 in FFY18 Title XX Base to HCDJFS, in exchange for  
27 those accepted funds.

29 SECTION 2

30  
31 The Chief Financial Officer of the County Executive's Department of Job and Family  
32 Services is hereby assigned as designee of the County to effectuate the transfers authorized in  
33 Section 1, pursuant to Section 5101:9-6-82(F)(3)(b).

35 SECTION 3

36  
37 This Resolution is hereby declared an emergency in the interest of the health, safety and  
38 welfare of the residents of the County of Summit and for the further reason to immediately  
39 authorize the transfer and acceptance of funds between SCDJFS and two local Counties'  
40 Department of Job and Family Services during the appropriate time period.

42 SECTION 4

43  
44 Provided this Resolution receives the affirmative vote of eight members, it shall take  
45 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
46 effect and be in force at the earliest time provided by law.
