7 **A Resolution authorizing the County Executive to execute any documents necessary to**
8 **accept a 2020 Statewide Search and Rescue Water grant from the Ohio Emergency**
9 **Management Agency, in the amount of \$6,000.00, with no local cash match requirement,**
10 **for the period 7/1/19 through 5/31/20, for the Executive’s Department of Law and Risk**
11 **Management-Division of Public Safety/ Emergency Management Agency, and declaring an**
12 **emergency.**

14 WHEREAS, the Ohio Emergency Management Agency (“OEMA”) has granted a 2020
15 Statewide Search and Rescue – Water Grant from the State Homeland Security Program to the
16 Summit County Emergency Management Agency, in the amount of \$6,000.00 for the period of
17 7/1/19 through 5/31/20; and

19 WHEREAS, the purpose of the grant is to help sustain the Region 5 water rescue
20 capabilities through the purchase of equipment, expendable materials and supplies; and

22 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
23 that it is necessary and in the best interest of the County of Summit to authorize the County
24 Executive to execute any documents necessary to accept the award of the aforementioned grant
25 from the OEMA;

27 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
28 of Ohio, that:

32 The County Executive is hereby authorized to execute any documents necessary to accept
33 the 2020 Statewide Search and Rescue - Water Grant from the Ohio Emergency Management
34 Agency (“OEMA”), for \$6,000.00, with no local cash match requirement, for the period 7/1/19
35 through 5/31/20.

39 This Resolution is hereby declared an emergency in the interest of the health, safety and
40 welfare of the residents of the County of Summit and for the further reason to immediately
41 authorize the Executive to execute any documents necessary to accept the award of a fiscal year
42 2020 Search and Rescue Grant from the OEMA so that the funds may be expended within the
43 grant period.

47 Provided this Resolution receives the affirmative vote of eight members, it shall take
48 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
49 effect and be in force at the earliest time provided by law.
