7 **A Resolution authorizing the County Executive to execute any documents necessary to**  
8 **accept a 2020 Statewide Search and Rescue Grant from the Ohio Emergency Management**  
9 **Agency, in the amount of \$7,250.00, with no local cash match requirement, for the period**  
10 **7/1/19 through 5/31/20, for the Executive's Department of Law and Risk Management-**  
11 **Division of Public Safety/Emergency Management Agency, and declaring an emergency.**

13 WHEREAS, the Ohio Emergency Management Agency ("OEMA") has granted a 2020  
14 Statewide Search and Rescue Grant to the Summit County Emergency Management Agency, in  
15 the amount of \$7,250.00, with no local cash match requirement, for the period 7/1/19 through  
16 5/31/20; and

18 WHEREAS, these funds will be utilized to continue to build and sustain the Region 5  
19 Type II collapse search and rescue capability, including costs associated with team  
20 administration, equipment and expendable materials and supply purchases, vehicle and  
21 equipment maintenance, exercises and training; and

23 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
24 that it is necessary and in the best interest of the County of Summit to authorize the County  
25 Executive to execute any documents necessary to accept the award of the aforementioned grant  
26 from the OEMA;

28 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
29 of Ohio, that:

33 The County Executive is hereby authorized to execute any documents necessary to accept  
34 the 2020 Statewide Search and Rescue Grant from the Ohio Emergency Management Agency  
35 ("OEMA"), in the amount of \$7,250.00, with no local cash match requirement, for the period  
36 7/1/19 through 5/31/20.

40 This Resolution is hereby declared an emergency in the interest of the health, safety and  
41 welfare of the residents of the County of Summit and for the further reason to immediately  
42 authorize the acceptance of the 2020 Search and Rescue Grant from the OEMA so that the grant  
43 funds may be expended within the grant period.

47 Provided this Resolution receives the affirmative vote of eight members, it shall take  
48 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
49 effect and be in force at the earliest time provided by law.
