7 **A Resolution confirming an award by the Board of Control of a construction contract with**
8 **J.D. Williamson Construction Co., Inc. for the rehabilitation of the Riverview Bridge in**
9 **Cuyahoga Falls, in Council District 3, in an amount not to exceed \$1,239,851.13, for the**
10 **Engineer, and declaring an emergency.**

12 WHEREAS, the Board of Control, at its November 27, 2019 meeting, awarded a
13 construction contract with J.D. Williamson Construction Co., Inc. for the rehabilitation of the
14 Riverview Bridge in Cuyahoga Falls, in Council District 3, in an amount not to exceed
15 \$1,239,851.13, subject to confirmation by County Council; and

17 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
18 that the aforementioned construction contract with J.D. Williamson Construction Co., Inc. is
19 necessary and in the best interest of the County of Summit;

21 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
22 of Ohio, that:

24 SECTION 1

26 The award by the Board of Control of a construction contract with J.D. Williamson
27 Construction Co., Inc. for the rehabilitation of the Riverview Bridge in Cuyahoga Falls, in
28 Council District 3, in an amount not to exceed \$1,239,851.13, is hereby confirmed and the
29 County Executive is hereby authorized to execute such construction contract and any other
30 necessary related documents.

34 This Resolution is declared an emergency in the interest of the health, safety and welfare
35 of the residents of the County of Summit and for the further reason to immediately confirm the
36 award of a necessary construction contract to rehabilitate the Riverview Bridge to begin as
37 expeditiously as possible.

41 Provided this Resolution receives the affirmative vote of eight members, it shall take
42 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
43 effect and be in force at the earliest time provided by law.

47 It is found and determined that all formal actions of the Council concerning and relating
48 to the adoption of the Resolution were adopted in an open meeting of this Council, and that all
49 deliberations of this Council and of any of its committees that resulted in such formal action,

51 121.22 of the Ohio Revised Code.


