A Resolution confirming the award by the Board of Control of an extension of a professional service contract with Akron General Partners, Inc., as a Best Practical Source, to perform biometric screenings services and flu shots, for a six month period, from 8/1/19 to 1/31/20, for an amount not to exceed \$30,000.00, for a total contract amount not to exceed \$84,000.00, for the Executive's Department of Human Resources-Division of Employee Benefits, and declaring an emergency,

WHEREAS, County Council previously adopted Resolution No. 2018-400, which confirmed an award by the Board of Control of a renewal (second and final) of a professional service contract with Akron General Partners, Inc. for biometric screening services and flu shots, for a one-year term, from 8/1/18 through 7/31/19, in an amount not to exceed \$54,000.00; and

WHEREAS, it is necessary to extend said professional service contract with Akron General Partners, Inc. for a six-month period, from 8/1/19 through 1/31/20, for an amount not to exceed \$27,000.00; and

WHEREAS, the Board of Control, at its November 13, 2019 meeting, awarded an extension of a professional service contract with Akron General Partners, Inc., as a Best Practical Source, to perform flu shots and biometric screenings for a six month period, from 8/1/19 through 1/31/20, for an amount not to exceed \$30,000.00, for a total contract amount not to exceed \$84,000.00, subject to confirmation by County Council; and

WHEREAS this Council finds and determines, after reviewing all pertinent information, that the aforementioned extension of the professional service contract with Akron General Partners, Inc. is necessary and in the best interest of the County of Summit;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

SECTION 1

The award by the Board of Control of an extension of a professional service contract with Akron General Partners, Inc., as a Best Practical Source, to perform flu shots and biometric screenings for a six month period, from 8/1/19 through 1/31/20, for an amount not to exceed \$30,000.00, for a total contract amount not to exceed \$84,000.00, is hereby confirmed and the County Executive is hereby authorized to execute said extension and any necessary related documents.

SECTION 2

This Resolution is hereby declared an emergency in the interest of the health, safety and welfare of the residents of the County of Summit, and for the further reason that it immediately provides for necessary biometric screenings and flu shots.
