7 **A Resolution authorizing the County Executive to sell, without conducting an auction, 95**  
8 **surplus chairs to Locust Dental Group for payment in the amount of \$6,175.00, for the**  
9 **Executive's Department of Job and Family Services, and declaring an emergency.**

11 WHEREAS, in 2017 the County Executive's Department of Job and Family Services  
12 purchased 300 Flex Flow Stack Chairs for the client's lobby at the Russell M. Pry Building; and

13  
14 WHEREAS, since that time, client traffic has decreased and the need for 95 chairs is no  
15 longer necessary; and

16  
17 WHEREAS, the County Executive wishes to sell, without conducting an auction, 95  
18 surplus chairs to Locust Dental Group, which is moving into the Pry Building, for payment in the  
19 amount of \$65.00 per chair, for a total amount of \$6,175.00, which requires the approval of  
20 County Council pursuant to Section 177.18(e) of the Codified Ordinances of the County of  
21 Summit; and

23 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
24 that it is necessary and in the best interest of the County of Summit to authorize the County  
25 Executive to sell, without conducting an auction, 95 surplus chairs to Locust Dental Group, for  
26 payment in the amount of \$65.00 per chair, for a total amount of \$6,175.00;

28 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
29 of Ohio, that:

31 SECTION 1

33 This Council hereby finds and determines, pursuant to Section 177.18(e) of the Codified  
34 Ordinances of the County of Summit, that due to the proximity of the buyer to the Executive's  
35 Department of Job and Family Services, there is good cause to not conduct a public auction to  
36 dispose of 95 surplus chairs. The County Executive is hereby authorized to sell, without  
37 conducting an auction, said 95 surplus chairs to Locust Dental Group for payment in the amount  
38 of \$65.00 per chair, for a total amount of \$6,175.00. The Executive is further authorized to  
39 execute any documents necessary to execute said sale.

43 This Resolution is hereby declared an emergency in the interest of the health, safety and  
44 welfare of the residents of the County of Summit and for further purpose of immediately  
45 authorizing the Executive to sell surplus chairs to Locust Dental Group.

49 Provided this Resolution receives the affirmative vote of eight members, it shall take  
50 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
51 effect and be in force at the earliest time provided by law.
