RESOLUTION NO. 2019-411

A Resolution authorizing the County Executive to execute a Member Community Infrastructure Grant Program agreement with the Northeast Ohio Regional Sewer District for the Crow Berkshire Area Inflow Elimination Project Q-161, located in the City of Macedonia, in Council District 1, and to execute any documents necessary to accept a grant from the District in a total amount not to exceed \$549,000.00, with no local cash match required, for the completion of the Project, for the Executive's Department of Sanitary Sewer Services, and declaring an emergency.

WHEREAS, the County of Summit and the Northeast Ohio Regional Sewer District ("District") wish to enter into a Member Community Infrastructure Grant Program agreement ("Agreement"), which is attached hereto as Exhibit "A" and incorporated herein by reference, for the Crow Berkshire Area Inflow Elimination Project Q-161 (the "Project"), and for the County to accept a grant from the District in a total amount not to exceed \$549,000.00, with no local cash match required, to complete the Project; and

WHEREAS, pursuant to Section 177.21 of the Codified Ordinances of the County of Summit, only the approval of County Council is required for intergovernmental agreements; and

WHEREAS, the District requires the legislative authority of the County to adopt legislation for the execution of the Agreement and the acceptance of its grant funds; and

WHEREAS, this Council finds and determines after reviewing all pertinent information, that it is necessary and in the best interest of the County of Summit to authorize the County Executive to execute the aforementioned Agreement with the Northeast Ohio Regional Sewer District and to accept its grant funds;

SECTION 1

The County Executive is hereby authorized to execute a Member Community Infrastructure Grant Program agreement ("Agreement") with the Northeast Ohio Regional Sewer District ("District") for the Crow Berkshire Area Inflow Elimination Project Q-161 (the "Project"), which is attached hereto as Exhibit A and incorporated fully herein, with such modifications and revisions as shall be in furtherance of the provisions of said Agreement and not substantially adverse to the County, all of which shall be conclusively evidenced by the execution thereof by the County Executive.
