7 **A Resolution authorizing the County Executive to execute a collective bargaining**
8 **agreement between Ohio Council 8 and Local 1229 of the American Federation of State,**
9 **County and Municipal Employees, AFL-CIO (Fiscal Office), and the County Executive and**
10 **the County Fiscal Officer, for the period 9/1/19 through 8/31/21, for the Executive and the**
11 **Fiscal Officer, and declaring an emergency.**

13 WHEREAS, a collective bargaining agreement has been reached between the County the
14 County Executive and Fiscal Officer, and Ohio Council 8 and Local 1229 of the American
15 Federation of State, County and Municipal Employees, AFL-CIO (Fiscal Office), for the period
16 9/1/19 through 8/31/21, which authorizes a two and one-half percent (2.5%) increase in pay in
17 each of the two years of the agreement; and

19 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
20 that is necessary and in the best interest of the County of Summit to authorize the Executive to
21 execute the aforementioned collective bargaining agreement;

23 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
24 of Ohio, that:

26 SECTION 1

28 The County Executive is hereby authorized to execute a collective bargaining agreement
29 between Ohio Council 8 and Local 1229 of the American Federation of State, County and
30 Municipal Employees, AFL-CIO (Fiscal Office), and the County Executive, for the period 9/1/19
31 through 8/31/21, which authorizes a two and one-half percent (2.5%) increase in pay in each of
32 the two years of the agreement.

34 SECTION 2

36 This Resolution is hereby declared an emergency in the interest of the health, safety, and
37 welfare of the citizens of the County of Summit and for the further purpose of providing a timely
38 collective bargaining agreement between Ohio Council 8 and Local 1229 of the American
39 Federation of State, County and Municipal Employees, AFL-CIO (Fiscal Office), and the County
40 Executive.

42 SECTION 3

44 Provided this Resolution received the affirmative vote of eight members, it shall take
45 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
46 effect and be in force at the earliest time provided by law.


