7 **A Resolution confirming an award by the Board of Control of a purchase contract with**
8 **Gov Connection, Inc., for the purchase of Mobile Data Terminals as lowest responsive and**
9 **responsible bidder, in an amount not to exceed \$220,801.14, for the Executive's**
10 **Department of Law and Risk Management-Division of Public Safety, and declaring an**
11 **emergency.**

13 WHEREAS, the Board of Control, at its meeting held September 25, 2019, awarded a
14 purchase contract with Gov Connection, Inc., for the purchase of Mobile Data Terminals as
15 lowest responsive and responsible bidder, in an amount not to exceed \$220,801.14, subject to
16 confirmation by County Council; and

18 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
19 that the aforementioned purchase contract with Gov Connection, Inc. is necessary and in the best
20 interest of the County of Summit;

22 NOW THEREFORE, BE IT RESOLVED, by the Council of the County of Summit, State
23 of Ohio, that:

27 The award by the Board of Control of a purchase contract with Gov Connection, Inc., for
28 the purchase of Mobile Data Terminals as lowest responsive and responsible bidder, in an
29 amount not to exceed \$220,801.14, is hereby confirmed and the County Executive is hereby
30 authorized to execute such purchase contract.

34 This Resolution is hereby declared an emergency in the interest of health, safety and
35 welfare of the residents of the County of Summit, and for the further reason to immediately
36 provide necessary mobile data terminals for law enforcement departments throughout Region 5.

40 Provided this Resolution receives the affirmative vote of eight members, it shall take
41 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
42 effect and be in force at the earliest time provided by law.

46 It is found and determined that all formal actions of this Council concerning and relating
47 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
48 deliberations of this Council and of any of its committees that resulted in such formal action,

50 121.22 of the Ohio Revised Code.
