- A. - 1. The Lease is renewed for an additional term of one (1) year, from November 20, 2019 through November 19, 2020.
- 2. In the event of any conflict between the terms and conditions of this First Renewal of the Lease and Addendum and the terms and conditions contained in the underlying Lease Agreement and Addendum, the provisions of this First Renewal of the Lease and Addendum shall control. All other, non-conflicting terms and conditions of

the Lease, including the terms and conditions of the Addendum attached to the Lease shall remain in effect.
