A Resolution authorizing the County Executive to execute a one-year renewal (first of four) of a lease agreement and an addendum to the lease agreement with United Disability Services, Inc. for space located at Summit County Children Services, in Council District 4, for cafeteria operations, from 11/20/19 through 11/19/20, , for the Executive's Department of Law and Risk Management, and declaring an emergency.

WHEREAS, County Council previously adopted Resolution No. 2018-417, which authorized the County Executive to execute a one-year lease agreement and an addendum to the lease agreement (collectively the "Lease") with United Disability Services, Inc. ("UDS") for approximately 1,280 square feet of space located at Summit County Children Services ("SCCS"), 264 South Arlington Street, Akron, Ohio 44306, in Council District 4, for cafeteria operations, for the period 11/20/18 through 11/19/19, with four options to renew for an additional one-year term, for rent in the amount of \$1.00 per year; and;

WHEREAS, County, SCCS and UDS wish to enter into a renewal (first of four) of the Lease, for a one-year term, from 11/20/19 through 11/19/20, for rent in the amount of \$1.00 per year; and

WHEREAS, because UDS is a nonprofit corporation and is leasing the space for educational and/or charitable purposes, only the approval of County Council is required pursuant to Section 177.17(e) of the Codified Ordinances of County of Summit; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the County of Summit to authorize the Executive to execute the aforementioned renewal (first of four) of the Lease, for the aforementioned reasons;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

SECTION 1

RESOLUTION NO.

The County Executive is hereby authorized to execute a renewal (first of four) of one-year lease agreement and an addendum to the lease agreement and the addendum to the lease agreement with United Disability Services, Inc. ("UDS") for approximately 1,280 square feet of space located at Summit County Children Services ("SCCS"), 264 South Arlington Street, Akron, Ohio 44306, in Council District 4, for cafeteria operations, for the period 11/20/19 through 11/19/20, for rent in the amount of \$1.00 per year, a copy of said lease agreement and addendum to the lease agreement being attached hereto as Exhibit A and incorporated fully herein, with such modifications and revisions as shall be in furtherance of the provisions of said renewal of the lease agreement and the addendum to the lease agreement and not substantially adverse to the County, all of which shall be conclusively evidenced by the execution thereof by the County Executive.
