7 **An amended Resolution authorizing the County Executive to execute an intergovernmental**
8 **agreement with the Summit County Combined General Health District dba Summit**
9 **County Public Health for Adult Protective Services for nurse and sanitarian services for a**
10 **one-year term, from 10/1/19 through 9/30/20, in an amount not to exceed ~~\$293,000.00~~**
11 **\$100,000.00, for the Executive's Department of Job and Family Services, and declaring an**
12 **emergency.**

14 WHEREAS, the County wishes to enter into an intergovernmental agreement with the
15 Summit County Combined General Health District dba Summit County Public Health for Adult
16 Protective Services for nurse and sanitarian services for a one-year term, from 10/1/19 through
17 9/30/20, in an amount not to exceed ~~\$293,000.00~~ \$100,000.00; and

19 WHEREAS, pursuant to Section 177.21 of the Codified Ordinances of the County of
20 Summit, only the approval of County Council is required for intergovernmental agreements; and

22 WHEREAS, this Council finds and determines, after reviewing all pertinent information
23 that it is necessary and in the best interest of the County Summit to authorize the County
24 Executive to execute the aforementioned intergovernmental with the Summit County Combined
25 General Health District dba Summit County Public Health;

27 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
28 of Ohio, that:

32 The County Executive is hereby authorized to execute an intergovernmental agreement
33 with the Summit County Combined General Health District dba Summit County Public Health
34 for Adult Protective Services for nurse and sanitarian services, as more fully set forth in Exhibit
35 A, attached hereto and incorporated herein as if fully restated, for a one-year term, from 10/1/19
36 through 9/30/20, in an amount not to exceed ~~\$293,000.00~~ \$100,000.00.

40 This Resolution is hereby declared an emergency in the interest of the health, safety and
41 welfare of the residents of the County of Summit, and for the further reason to immediately
42 provide for Adult Protective Services for nurse and sanitarian services effective 10/1/19.

47 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
