7 **A Resolution pursuant to Section 177.13 of the Codified Ordinances of the County of**
8 **Summit, authorizing purchases by the Court of Common Pleas-General Division, Adult**
9 **Probation Department, subject to the approval of the Board of Control, from the**
10 **Community Health Center, as a Best Practical Source, for drug screen testing services, in a**
11 **total aggregate amount not to exceed \$100,000.00, in calendar year 2019, for the Court of**
12 **Common Pleas-General Division, Adult Probation Department, and declaring an**
13 **emergency.**

15 WHEREAS, Section 177.13 of the Codified Ordinances of the County of Summit
16 requires that purchases of an officeholder exceeding \$50,000.00 in aggregate in any calendar
17 year, where no additional competitive quotes or bids have been taken, shall be made only upon
18 authorization of County Council; and

20 WHEREAS, the County Executive's Department of Finance and Budget and the Board of
21 Control have previously approved purchases by the Court of Common Pleas-General Division,
22 Adult Probation Department from the Community Health Center, as a Best Practical Source, for
23 drug screen testing services, in the aggregate amount of \$50,000.00, for calendar year 2019; and

25 WHEREAS, the Court of Common Pleas-General Division, Adult Probation Department
26 anticipates additional purchases, subject to the approval of the Board of Control, from
27 Community Health Center, as a Best Practical Source, for drug screen testing services, in an
28 additional amount not to exceed \$50,000.00, for a total aggregate amount not to exceed
29 \$100,000.00 in calendar year 2019; and

31 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
32 that it is necessary and in the best interest of the County of Summit to authorize purchases by the
33 Court of Common Pleas-General Division, Adult Probation Department from the Community
34 Health Center, subject to the approval of the Board of Control, as a Best Practical Source, for
35 drug screen testing services, in a total aggregate amount not to exceed \$100,000.00 in calendar
36 year 2019;

38 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
39 of Ohio, that:

43 This Council hereby authorizes purchases by the Court of Common Pleas-General
44 Division, Adult Probation Department, subject to the approval of the Board of Control, from the
45 Community Health Center, as a Best Practical Source, for drug screen testing services, in an
46 additional amount not to exceed \$50,000.00, for a total aggregate amount not to exceed
47 \$100,000.00, in calendar year 2019.

14 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
15 effect and be in force at the earliest time provided by law.
