7 **A Resolution adjusting existing appropriations in a total amount of \$100,000.00, for the**
8 **Executive's Department of Sanitary Sewer Services-Division of Building Standards, and**
9 **declaring an emergency.**

11 WHEREAS, the difficulty in filling the position of a master plans examiner coupled with
12 other staff turnover and vacancies has freed up salary appropriations for other uses for the
13 Executive's Department of Sanitary Sewer Services - Division of Building Standards; and

14
15 WHEREAS, an increased volume of plan submittals coupled with staff vacancies has
16 necessitated the need for additional funds to retain qualified outside contractors to perform plan
17 reviews for the plan permitting process thus necessitating the need to transfer \$60,000.00 of
18 unused salary appropriations to Contract Services; and

20 WHEREAS, additionally, the high volume of revenue collected for permit fees has
21 increased associated expenses for State of Ohio fees, necessitating the need to transfer
22 \$40,000.00 of unused salary appropriations to Other; and

24 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
25 that it is necessary and in the best interest of the County of Summit to transfer funds from the
26 Salaries account to Contract Services and Other accounts for the Division of Building Standards,
27 in a total amount of \$100,000.00;

29 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State


