A Resolution confirming an award by the Board of Control of a construction contract with Lockhart Concrete Co. in an amount not to exceed \$624,460.00 for the construction of the Indian Creek Exposed Sanitary Sewer Project Q-180 — Contract 2 (the "Project") located in the City of Macedonia, in Council District 1, and authorizing the County Executive to apply for and execute a Cooperative Agreement with the Ohio Water Development Authority for a loan in an amount not to exceed \$686,906.00 to fund the Project, and appropriating funds, for the Executive's Department of Sanitary Sewer Services, and declaring an emergency.

WHEREAS, the Board of Control, at its meeting held September 18, 2019, awarded a construction contract with Lockhart Concrete Co., for the Indian Creek Exposed Sanitary Sewer Project Q-180 – Contract 2 (the "Project"), located in the City of Macedonia, in Council District 1, in an amount not to exceed \$624,460.00, subject to confirmation by County Council; and

WHEREAS, the County intends to apply for an Ohio Water Development Authority ("OWDA") loan to finance the construction of the Project; and

WHEREAS, the OWDA requires the legislative authority of the County to adopt legislation for the application of loans, the execution of agreements, and the designation of dedicated repayment sources; and

WHEREAS, the amount of the OWDA loan must include a 10% contingency amount and fees as required by OWDA, for a total loan amount not to exceed \$686,906.00; and

WHEREAS, it is necessary to appropriate funds for the completion of the aforementioned Project; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information that it is necessary and in the best interest of the County of Summit to authorize the County Executive to execute the construction contract with Lockhart Concrete Co., to authorize the County Executive to apply for and execute a Cooperative Agreement with OWDA for the aforementioned loan, and to appropriate funds;
