7 **A Resolution authorizing the County Executive to execute an intergovernmental agreement**
8 **with the County of Summit Alcohol, Drug Addiction and Mental Health Services Board to**
9 **accept a Specialized Docket Subsidy, for the period 7/1/19 through 6/30/20, in the amount**
10 **of \$120,000.00, with no local cash match requirement, for the Court of Common Pleas-**
11 **Juvenile Division, and declaring an emergency.**

13 WHEREAS, the Ohio Department of Mental Health and Addiction Services
14 (“ODMHAS”) has allocated specialized docket subsidies to the County of Summit Alcohol,
15 Drug Addiction and Mental Health Services Board (“ADM”) to assist drug courts and other
16 specialized dockets with funding to effectively manage addicted offenders in the community; and

19 WHEREAS, it is necessary to authorize the County Executive to execute any documents
20 necessary to accept the specialized docket subsidy from ADM to the Court of Common Pleas-
21 Juvenile Division for the period 7/1/19 through 6/30/20, in the amount of \$120,000.00, with no
22 local cash match requirement; and

24 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
25 that it is necessary and in the best interest of the County of Summit to authorize the Executive to
26 execute any documents necessary to accept the aforementioned grant funds from ADM;

28 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
29 of Ohio, that:

31 SECTION 1

32

33 The County Executive is hereby authorized to execute an intergovernmental agreement
34 with the County of Summit Alcohol, Drug Addiction, and Mental Health Services Board
35 (“ADM”) to accept a Specialized Docket Subsidy, for the period 7/1/19 through 6/30/20, in the
36 amount of \$120,000.00, for the Court of Common Pleas-Juvenile Division, which is attached
37 hereto as Exhibit A and incorporated fully herein, with such modifications and revisions as shall
38 be in furtherance of the provisions of said intergovernmental agreement and not substantially
39 adverse to the County, all of which shall be conclusively evidenced by the execution thereof by
40 the County Executive. The County Executive is hereby authorized to execute any additional
41 necessary documents related to said grant.

43 SECTION 2

45 This Resolution is declared an emergency in the interest of the health, safety and welfare
46 of the residents of the County of Summit and for the further purpose of immediately authorizing
47 the acceptance of the ADM Specialized Docket subsidy grant so that funds may be used
48 immediately.

50 SECTION 3

52 Provided this Resolution receives the affirmative vote of eight members, it shall take
effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
