7 **A Resolution adjusting existing appropriations, in the amount of \$2,274.43, from the Salary**  
8 **account to the Benefits account for the Program Year 2018 Home Weatherization**  
9 **Assistance Program Fund, for the County Executive's Department of Community and**  
10 **Economic Development, and declaring an emergency.**

12 WHEREAS, County Council previously adopted Resolution 2018-341, which authorized  
13 the County Executive to execute any documents necessary to accept grants from the U.S.  
14 Department of Energy and the U.S. Department of Health and Human Services for the Home  
15 Weatherization Assistance Program for the program year from 7/1/18 through 6/30/19, in a total  
16 amount of \$1,044,559.00, with no local cash match requirement, and appropriated said funds, for  
17 the County Executive's Department of Community and Economic Development; and

19 WHEREAS, it is necessary to adjust existing appropriations, in the amount of \$2,274.43,  
20 from the Labor account to the Benefits account, because benefits were underestimated in that  
21 amount; and

23 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
24 that the aforementioned adjustment of appropriations is necessary and in the best interest of the  
25 County of Summit;

16 121.22 of the Ohio Revised Code.


