7 **A Resolution certifying delinquent Surface Water Management District charges to the**
8 **Fiscal Officer, for the Engineer, and declaring an emergency.**

10 WHEREAS, the billing records at the Summit County Engineer's office show delinquent
11 surface water utility accounts which represent unpaid charges; and

12
13 WHEREAS, Section 942.07(d) of the County of Summit Codified Ordinances provides
14 that these charges are to be certified to the County Fiscal Officer and placed on the property tax
15 duplicate for collection; and

16
17 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
18 that it is necessary and in the best interest of the County of Summit to certify the aforementioned
19 charges to the Fiscal Officer;

21 NOW, THEREFORE, BE IT ORDAINED by the Council of the County of Summit, State
22 of Ohio, that;

24 SECTION 1

26 The delinquent surface water utility accounts listed in Exhibit A are hereby certified to
27 the County Fiscal Officer to be placed on the tax list and duplicate on their respective Parcels for
28 collection as other taxes are collected.

32 The Clerk of Council shall deliver a copy of this Resolution to the Fiscal Officer who
33 shall record the delinquent surface water utility charges for collection pursuant to the County of
34 Summit Codified Ordinances.

38 This Resolution is hereby declared an emergency in the interest of the health, safety, and
39 welfare of the residents of the County of Summit, and for the further reason to immediately
40 ensure the certification of charges to the Fiscal Officer.

44 Provided this resolution receives the affirmative vote of eight members, it shall take
45 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
46 effect and be in force at the earliest time provided by law.
