7 **A Resolution authorizing the County Executive to establish the intersection of Riverview**
8 **Road and Boston Mills Road in Boston Township, in Council District 1, as a temporary 4-**
9 **way stop intersection for the period of 9/16/19 to 9/30/19, and thereafter said intersection**
10 **shall revert to a 2-way stop intersection with the stop signs installed for the eastbound and**
11 **westbound Boston Mills Road traffic, for the Engineer, and declaring an emergency.**

13 WHEREAS, Section 5553.02 of the Ohio Revised Code grants authority to locate, alter,
14 or vacate roads to the board of county commissioners; and

15
16 WHEREAS, Section 5553.04 of the Ohio Revised Code establishes the procedure for
17 establishing, altering, or vacating roads; and

18
19 WHEREAS, the Cuyahoga Valley Scenic Railroad desires to celebrate the “Steam in the
20 Valley” event, and has asked the Engineer to assist in traffic control by establishing a 4-way stop
21 at the intersection of Riverview Road and Boston Mills Road due to the increased vehicular and
22 pedestrian traffic anticipated during the time of this event; and

24 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
25 that it is necessary and in the best interest of the County to authorize the County Executive to
26 establish the intersection of Riverview Road and Boston Mills Road in Boston Township, in
27 Council District 1, as a temporary 4-way stop intersection for the period of 9/16/19 to 9/30/19,
28 and thereafter said intersection shall revert to a 2-way stop intersection with the stop signs
29 installed for the eastbound and westbound Boston Mills Road traffic;

31 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
32 of Ohio, that:

34 SECTION 1

36 The Summit County Executive is hereby authorized to establish the intersection of
37 Riverview Road and Boston Mills Road in Boston Township, in Council District 1, as a
38 temporary 4-way stop intersection for a period 9/16/19 to 9/30/19, and thereafter said
39 intersection shall revert to a 2-way stop intersection with the stop signs installed for the
40 eastbound and westbound Boston Mills Road traffic.

44 This Resolution is hereby declared an emergency in the interest of the health, safety and
45 welfare of the residents of the County of Summit, and for the further reason that it immediately
46 ensures safe travel for pedestrians and workers for the “Steam in the Valley” event.



16 121.22 of the Ohio Revised Code.


