7 **A Resolution confirming an award by the Board of Control of a renewal (first and final) of**
8 **a professional service contract with Opportunity Parish Ecumenical Neighborhood**
9 **Ministry to provide job readiness services for work mandated Abled Bodied Adults**
10 **Without Dependents receiving Food Assistance Employment and Training program**
11 **benefits, for a one-year term, from 10/1/19 through 9/30/20, in an amount not to exceed**
12 **\$138,000.00, for the Executive's Department of Job and Family Services, and declaring an**
13 **emergency.**

15 WHEREAS, the Board of Control, at its meeting held August 14, 2019, awarded the
16 renewal (first and final) of a professional service contract with Opportunity Parish Ecumenical
17 Neighborhood Ministry ("OPEN M") to provide job readiness services for work mandated Abled
18 Bodied Adults Without Dependents ("ABAWD") receiving Food Assistance Employment and
19 Training ("FAET") program benefits, for a one-year term, from 10/1/19 through 9/30/20, in an
20 amount not to exceed \$138,000.00, subject to confirmation by County Council; and

22 WHEREAS, this Council finds and determines, after reviewing all pertinent information
23 that the aforementioned professional service contract with OPEN M is necessary and in the best
24 interest of the County of Summit;

26 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
27 of Ohio, that:

31 The award by the Board of Control of a renewal (first and final) of a professional service
32 contract with Opportunity Parish Ecumenical Neighborhood Ministry ("OPEN M") to provide
33 job readiness services for work mandated Abled Bodied Adults Without Dependents
34 ("ABAWD") receiving Food Assistance Employment and Training ("FAET") program benefits,
35 for a one-year term, from 10/1/19 through 9/30/20, in an amount not to exceed \$138,000.00, is
36 hereby confirmed and the County Executive is hereby authorized to execute such professional
37 service contract.

41 This Resolution is hereby declared an emergency in the interest of the health, safety and
42 welfare of the residents of the County of Summit, and for the further reason to immediately
43 provide for job readiness services for work mandated ABAWD effective 10/1/19.

47 Provided this Resolution receives the affirmative vote of eight members, it shall take
48 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
49 effect and be in force at the earliest time provided by law.




