24 THEREFORE, BE IT ORDAINED by the Council of the County of Summit, State of

29 The Ordinances and Resolutions of the County of Summit, Ohio, enacted between May,
30 1, 2018 and May 1, 2019, all of which have been previously enacted and adopted by the County
31 Council, are hereby approved as numbered or renumbered and printed in the 2019 Replacement
32 Pages as prepared by the Walter H. Drane Company, of Cleveland, Ohio.

36 The sections of the Traffic and General Offenses Codes as listed in Appendix A and
37 attached as Exhibit A - of this ordinance are hereby added, amended or repealed as respectively
38 indicated in order to comply with current State law.

SECTION 4

This Ordinance is hereby declared an emergency to provide an additional means of exercise of powers and administration over local matters for the County of Summit in the interest of the health, safety, and welfare of the citizens of the County of Summit.

SECTION 5

Provided this Ordinance receives the affirmative vote of eight members, it shall take effect immediately upon its adoption and approval by the Executive; otherwise, it shall take effect and be in full force at the earliest time provided by law.

SECTION 6

It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.


