7 **A Resolution confirming an award by the Board of Control of professional service**
8 **contracts with certain providers for behavioral health and juvenile justice services, for the**
9 **period 7/1/19 through 6/30/20, in a total amount not to exceed \$201,180.00, for the Court of**
10 **Common Pleas-Juvenile Division, and declaring an emergency.**

12 WHEREAS, the Board of Control, at its meeting held July 3, 2019, awarded professional
13 service contracts with certain providers for behavioral health and juvenile justice services, for the
14 period 7/1/19 through 6/30/20, in a total amount not to exceed \$201,180.00, subject to
15 confirmation by County Council; and

17 WHEREAS, a list of providers is attached as Exhibit A; and

19 WHEREAS, this Council finds and determines after reviewing all pertinent information,
20 that the aforementioned professional service contracts with certain providers are necessary and in
21 the best interest of the County of Summit;

23 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

28 The award by the Board of Control of professional service contracts with certain
29 providers for behavioral health and juvenile justice services, as set forth in Exhibit A, attached to
30 this Resolution and incorporated herein as if fully restated, for the period 7/1/19 through 6/30/20,
31 in a total amount not to exceed \$201,180.00, is hereby confirmed and the County Executive is
32 hereby authorized to execute the aforementioned professional service contracts.

36 This Resolution is hereby declared an emergency in the interest of the health, safety and
37 welfare of the residents of the County of Summit, and for the further reason to immediately
38 provide for behavioral health and justice services to the Court of Common Pleas-Juvenile
39 Division effective 7/1/19.

43 Provided this Resolution receives the affirmative vote of eight members, it shall take
44 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
45 effect and be in force at the earliest time provided by law.

10 121.22 of the Ohio Revised Code.


