7 **A Resolution authorizing the County Executive to advertise for bids for a robot for the**
8 **Mansfield Police Department Special Weapons and Tactics Team and Richland County**
9 **Allied Special Operations Response Team, for an estimated total cost not to exceed**
10 **\$70,240.00, for the Executive’s Department of Law and Risk Management – Division of**
11 **Public Safety, and declaring an emergency.**

13 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit
14 requires this Council’s authorization for the County Executive to advertise for bids; and

15
16 WHEREAS, the County Executive wishes to advertise for bids for a robot for the
17 Mansfield Police Department Special Weapons and Tactics Team (“SWAT”) and Richland
18 County Allied Special Operations Response Team (“ASORT”), in support of Ohio Homeland
19 Region 5 and the 10 county METRICH region, to enhance capabilities during a high risk
20 incident, for an estimated total cost not to exceed \$70,240.00; and

22 WHEREAS, a copy of the bid specifications is on file in the Clerk of Council’s office;

25 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
26 that is necessary and in the best interest of the County of Summit to authorize the Executive to
27 advertise for bids for a robot for the Mansfield Police Department SWAT and Richland County
28 ASORT;

30 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
31 of Ohio, that;

35 The County Executive is authorized to advertise for a robot for the Mansfield Police
36 Department Special Weapons and Tactics Team (“SWAT”) and Richland County Allied Special
37 Operations Response Team (“ASORT”), in support of Ohio Homeland Security Region 5 and the
38 10 county METRICH region, to enhance capabilities during a high risk incident, for an estimated
39 total cost not to exceed \$70,240.00.

43 This Resolution is declared an emergency in the interest of the health, safety, and welfare
44 of the residents of the County of Summit, and for the further reason that it authorizes the
45 Executive to immediately advertise for bids for the robot in order to procure the necessary
46 equipment for the Mansfield Police Department SWAT and Richland County ASORT within the
47 grant performance period.

8 effect and be in force at the earliest time provided by law.



16 121.22 of the Ohio Revised Code.


