11 WHEREAS, County Council has the authority pursuant to Article III, Section 3.03 (10)
12 of the Charter of the County of Summit and Sections 169.08, 169.09, 169.10 and 169.11 of the
13 Codified Ordinances to establish classifications and classification specifications for all County
14 employees; and

16 WHEREAS, at its June 20, 2019 meeting, at the request of the County Executive's
17 Department of Human Resources, the Human Resource Commission approved the new
18 classification specification for the non-bargaining, classified position of Employment Services
19 Counselor, #25021, as stated in Order 19-01, attached hereto as Exhibit A; and

21 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
22 it is necessary and in the best interest of the County of Summit to approve the new classification
23 specification for the non-bargaining, classified position of Employment Services Counselor,
24 #25021;

39 is assigned the salary schedule of Category 2, Grade 4.

44 welfare of the citizens and employees of the County of Summit, and for the further reason that it
45 is necessary in order to immediately approve the new classification specification for the non-




