12 **Office of Information Technology, and declaring an emergency.**

14 WHEREAS, the Board of Control, at its meeting held June 12, 2019, awarded a
15 professional service contract with Telecommunication Technologies Group, LLC, at less than
16 State Term Pricing, for cellular support services, including analysis of current cellular services,
17 bill review and contract management and consulting, for a two-year term, with two options to
18 renew for additional two-year terms, for a total amount not to exceed \$72,000.00, subject to
19 confirmation by County Council; and

21 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
22 that the aforementioned purchase contract with Telecommunication Technologies Group, LLC,
23 is necessary and in the best interest of the County of Summit;

30 The award by the Board of Control of a professional service contract with
31 Telecommunication Technologies Group, LLC, at less than State Term Pricing, for cellular
32 support services, including analysis of current cellular services, bill review and contract
33 management and consulting, for a two-year term, with two options to renew for additional two-
34 year terms, for a total amount not to exceed \$72,000.00, is hereby confirmed and the County
35 Executive is hereby authorized to execute such professional service contract.

39 This Resolution is hereby declared an emergency in the interest of the health, safety and
40 welfare of the residents of the County of Summit, and for the further reason to immediately
41 authorize necessary cellular support services for the County.

46 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
