7 **A Resolution confirming an award by the Board of Control of an amendment to a**
8 **professional service contract with the Battered Women’s Shelter of Summit and Medina**
9 **Counties for family stability case management and homeless prevention services funded by**
10 **the State Fiscal Year 2019 Temporary Assistance to Needy Families program, to increase**
11 **the amount of the contract by \$198,000.00 (53.54% cumulative increase), for a total**
12 **amount not to exceed \$998,000.00, for the Executive’s Department of Job and Family**
13 **Services, and declaring an emergency.**

15 WHEREAS, the Board of Control, at its meeting held June 12, 2019, awarded an
16 amendment to a professional service contract with the Battered Women’s Shelter of Summit and
17 Medina Counties for family stability case management and homeless prevention services funded
18 by the State Fiscal Year 2019 Temporary Assistance to Needy Families program, to increase the
19 amount of the contract by \$198,000.00 (53.54% cumulative increase), for a total amount not to
20 exceed \$998,000.00, subject to confirmation by County Council; and

22 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
23 that the aforementioned amendment to a professional service contract with the Battered
24 Women’s Shelter of Summit and Medina Counties is necessary and in the best interest of the
25 County of Summit;

27 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
28 of Ohio, that:

32 The award by the Board of Control of an amendment to a professional service contract
33 with the Battered Women’s Shelter of Summit and Medina Counties for family stability case
34 management and homeless prevention services funded by the State Fiscal Year 2019 Temporary
35 Assistance to Needy Families program, to increase the amount of the contract by \$198,000.00
36 (53.54% cumulative increase), for a total amount not to exceed \$998,000.00, is hereby confirmed
37 and the County Executive is hereby authorized to execute such amendment to a professional
38 service contract and any other necessary related documents.

42 This Resolution is hereby declared an emergency in the interest of the health, safety and
43 welfare of the residents of the County of Summit, and for the further reason to immediately
44 authorize the County Executive to execute the amendment to the aforementioned professional
45 service contract in order to enable the Battered Women’s Shelter of Summit and Medina
46 Counties to continue to provide necessary services as expeditiously as possible.
