7 **A Resolution confirming an award by the Board of Control of an amendment to a**
8 **professional service contract with Greenleaf Family Center, extending the original term of**
9 **the contract from 12/31/19 through 6/30/20 and providing an additional amount not to**
10 **exceed \$99,450.00, (a 75.77 % increase) for a total contract amount not to exceed**
11 **\$230,700.00 to provide assessments to identify individuals who may require enhanced**
12 **Court services through the Summit County Targeted Community Alternatives to Prison**
13 **plan, for the Executive's Department of Law and Risk Management – Division of Public**
14 **Safety, and declaring an emergency.**

16 WHEREAS, the Board of Control, at its meeting held June 12, 2019, awarded an
17 amendment to the professional service contract with Greenleaf Family Center extending the
18 original term of the contract from 12/31/19 through 6/30/20 and providing an additional amount
19 not to exceed \$99,450.00, (a 75.77 % increase) for a total contract amount not to exceed
20 \$230,700.00 to provide assessments to identify individuals who may require enhanced Court
21 services through the Summit County Targeted Community Alternatives to Prison plan, subject to
22 confirmation by County Council; and

24 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
25 that the aforementioned amendment to professional service contract with Greenleaf Family
26 Center is necessary and in the best interest of the County of Summit;

28 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

33 The award by the Board of Control of an amendment to a professional service contract
34 with Greenleaf Family Center extending the original term of the contract from 12/31/19 through
35 6/30/20 and providing an additional amount not to exceed \$99,450.00, (a 75.77 % increase) for a
36 total contract amount not to exceed \$230,700.00 to provide assessments to identify individuals
37 who may require enhanced Court services through the Summit County Targeted Community
38 Alternatives to Prison plan, is hereby confirmed and the County Executive is hereby authorized
39 to execute such amendment to a professional service contract and any other necessary related
40 documents.

44 This Resolution is hereby declared an emergency in the interest of health, safety and
45 welfare of the residents of the County of Summit, and for the further reason to immediately
46 continue support of the Summit County Targeted Community Alternatives to Prison plan.

51 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
