A Resolution authorizing the County Executive to execute an intergovernmental agreement with The North Hills Water District concerning the Twinsburg Road Culvert Replacement Project, located in Northfield Center Township, in Council District 1, for the Engineer, and declaring an emergency.

WHEREAS, the County Engineer has determined Twinsburg Road Culvert #112-13461, located approximately two-hundred feet west of Walters Road, in Northfield Center Township, in Council District 1, is in need of replacement ("the Project"); and

WHEREAS, The North Hills Water District has determined that the waterline located underneath the Twinsburg Road Culvert needs to be relocated and has requested that the County include in the Project the relocation and lowering of the waterline; and

WHEREAS, an intergovernmental agreement is required to outline the responsibilities and financial contributions for the County and The North Hills Water District for the construction of the Project, where each entity pays the contractor directly for their portion of work, as detailed in Exhibit A; and

WHEREAS, this Council has determined by reviewing all pertinent information that it is necessary and in the best interest of the County of Summit to authorize the County Executive to execute the aforementioned intergovernmental agreement with The North Hills Water District for the aforementioned Project;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that;

SECTION 1

The County Executive is hereby authorized to execute an intergovernmental agreement with The North Hills Water District to outline responsibilities and financial contributions for the Twinsburg Road Culvert Replacement Project, located in Northfield Center Township, in Council District 1, a copy of which is attached hereto as Exhibit A and incorporated fully herein with such modifications and revisions as shall be furtherance of the provisions of said intergovernmental agreement and not substantially adverse to the County, all of which shall be conclusively evidenced by the execution thereof by the County Executive.

SECTION 2

This Resolution is hereby declared an emergency in the interest of the health, safety and welfare of the residents of the County of Summit, and for the further purpose to immediately allow the Executive to execute said agreement and allow the North Hills Water District and the County Engineer to proceed with a project to replace a deteriorating culvert and relocate a nearby waterline.
