7 **An Ordinance amending Section 923.01(d) of the Codified Ordinances of the County of**
8 **Summit, entitled “User Charges,” to update the estimated sewage flow guidelines, for the**
9 **Executive’s Department of Sanitary Sewer Services, and declaring an emergency.**

11 WHEREAS, the Ohio Environmental Protection Agency uses its Greenbook to
12 periodically update the State’s sewage flow guidelines, and it is necessary to amend the flow
13 guidelines listed in Section 923.01(d) of the Codified Ordinances of the County of Summit,
14 entitled “User Charges,” to accurately reflect the current usage guidelines, as amended; and

15
16 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
17 that it is necessary and in the best interest of the County to amend Section 923.01(d) of the
18 Codified Ordinances for the aforementioned reason;

20 NOW THEREFORE, BE IT ORDAINED, by Council of the County of Summit, State of
21 Ohio, that:

22 SECTION 1

23
24 Section 923.01(d) of the Codified Ordinances of the County of Summit, entitled “User
25 Charges,” is hereby amended as set forth on Exhibit A, attached hereto and incorporated herein
26 by reference.

28 SECTION 2

30 This Ordinance is hereby declared an emergency in the interest of the health, safety and
31 welfare of the residents of the County of Summit, and for the further reason to immediately
32 amend Section 923.01(d) of the Codified Ordinances to incorporate the updates to the Ohio
33 Environmental Protection Agency’s estimated sewage flow guidelines, as amended.

35 SECTION 3

37 Provided this Ordinance receives the affirmative vote of eight members, it shall take
38 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
39 effect and be in force at the earliest time provided by law.

43 It is found and determined that all formal actions of the Council concerning and relating
44 to the adoption of the Ordinance were adopted in an open meeting of this Council, and that all
45 deliberations of this Council and of any of its committees that resulted in such formal action,
46 were in meetings open to the public, in compliance with all legal requirements, including Section
47 121.22 of the Ohio Revised Code.




