A Resolution authorizing the County Executive to execute an addendum, and any documents necessary, to increase by \$57,230.00 the State Fiscal Year 2018/2019 award of a Justice Reinvestment and Incentive Grant from the Ohio Department of Rehabilitation and Correction, Division of Parole and Community Sanctions, with a period extension to expend the funds through 6/30/21, with no local cash match requirement, and appropriating said grant funds, for the Court of Common Pleas-General Division, and declaring an emergency.

WHEREAS, this Council previously adopted Resolution No. 2017-550 which authorized the County Executive to execute any documents necessary to accept the award by the Ohio Department of Rehabilitation and Correction, Division of Parole and Community Sanctions of a Juvenile Reinvestment and Incentive Grant ("JRIG") to reduce probation violations, in State Fiscal Years 2018 and 2019 ("FY18/19"), in the amount of \$168,435.00, with no local cash match requirement, and appropriating funds for County Fiscal Year 2018;and

WHEREAS, the Ohio Department of Rehabilitation and Correction, Division of Parole and Community Sanctions has awarded additional JRIG funds for FY18/19 in the amount of \$57,230 to the Court of Common Pleas-General Division to help support the community corrections program/service, with a period extension to expend the funds through 6/30/21, with no local cash match requirement; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the County of Summit to authorize the County Executive to execute an addendum, and any documents necessary, to accept additional funds from the Ohio Department of Rehabilitation and Correction, Division of Parole and Community Sanctions as set forth above;

NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:
