7 **A Resolution confirming an award by the Board of Control of a professional service**
8 **contract with Oriana House, Inc., as a Best Practical Source, for community corrections**
9 **services to divert misdemeanor offenders from jail funded through the Community**
10 **Corrections Act 408 grant, for the period 7/1/19 through 6/30/21, in an amount not to**
11 **exceed \$786,236.00, for the Executive's Department of Law and Risk Management -**
12 **Division of Public Safety, and declaring an emergency.**

14 WHEREAS, the Board of Control, at its meeting held May 29, 2019, awarded a
15 professional service contract with Oriana House, Inc., as a Best Practical Source, for community
16 corrections services to divert misdemeanor offenders from jail funded through the Community
17 Corrections Act 408 grant, for the period 7/1/19 through 6/30/21, in an amount not to exceed
18 \$786,236.00, subject to confirmation by County Council; and

20 WHEREAS, this Council finds and determines after reviewing all pertinent information,
21 that the aforementioned professional service contract with Oriana House, Inc. is necessary and in
22 the best interest of the County of Summit;

24 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

29 The award by the Board of Control of a professional service contract with Oriana House,
30 Inc., as a Best Practical Source, for community corrections services to divert misdemeanor
31 offenders from jail funded through the Community Corrections Act 408 grant, for the period
32 7/1/19 through 6/30/21, in an amount not to exceed \$786,236.00 is hereby confirmed and the
33 County Executive is hereby authorized to execute such professional service contract.

37 This Resolution is hereby declared an emergency in the interest of the health, safety and
38 welfare of the residents of the County of Summit, and for the further reason to immediately
39 provide for community corrections services to divert misdemeanor offenders from jail funded
40 through the Community Corrections Act 408 grant effective 7/1/19.

44 Provided this Resolution receives the affirmative vote of eight members, it shall take
45 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
