11 **of Law, Insurance, and Risk Management – Division of Public Safety, and declaring an**

14 WHEREAS, the Board of Control, at its meeting held May 29, 2019, awarded a
15 professional service contract with Oriana House, Inc., as a Best Practical Source, for community
16 corrections services funded through the Community Corrections Act 407 grant, for the period
17 7/1/19 through 6/30/21, in an amount not to exceed \$1,799,040.00, subject to confirmation by
18 County Council; and

20 WHEREAS, this Council finds and determines after reviewing all pertinent information,
21 that the aforementioned professional service contract with Oriana House, Inc. is necessary and in
22 the best interest of the County of Summit;

29 The award by the Board of Control of a professional service contract with Oriana House,
30 Inc., as a Best Practical Source, for community corrections services funded through the
31 Community Corrections Act 407 grant, for the period 7/1/19 through 6/30/21, in an amount not
32 to exceed \$1,799,040.00 is hereby confirmed and the County Executive is hereby authorized to
33 execute such professional service contract.

37 This Resolution is hereby declared an emergency in the interest of the health, safety and
38 welfare of the residents of the County of Summit, and for the further reason to immediately
39 provide for community corrections services funded through the Community Corrections Act 407
40 grant effective 7/1/19.
