WHEREAS, RECLAIM Ohio is an initiative developed in 1993 to address the State's overburdened juvenile justice system and allows local courts to target specific areas to divert youth from being institutionalized; and

WHEREAS, the Court of Common Pleas - Juvenile Division has been awarded a State Fiscal Year 2020 RECLAIM Ohio grant from the Ohio Department of Youth Services, for the period 7/1/19 through 6/30/20, in an estimated amount of \$4,050,428.30, with no local match requirement, for the Court to target specific areas to divert youth from becoming institutionalized; and

WHEREAS, it is necessary to appropriate said grant funds; and

WHEREAS, this Council finds and determines after reviewing all pertinent information that it is necessary and in the best interest of the County of Summit to authorize the County Executive to execute any documents necessary to accept the award of the aforementioned RECLAIM Ohio grant and to appropriate said grant funds;

NOW THEREFORE, BE IT RESOLVED, by the Council of the County of Summit, State of Ohio, that:

SECTION 1
