7 **A Resolution authorizing the County Executive to execute any documents necessary to**
8 **accept the award by the Ohio Department of Youth Services of a State Fiscal Year 2020**
9 **RECLAIM Ohio Grant, for the period 7/1/19 to 6/30/20, in the estimated amount of**
10 **\$4,050,428.30, with no local match requirement, and appropriating said grant funds, for**
11 **the Court of Common Pleas-Juvenile Division, and declaring an emergency.**

13 WHEREAS, RECLAIM Ohio is an initiative developed in 1993 to address the State's
14 overburdened juvenile justice system and allows local courts to target specific areas to divert
15 youth from being institutionalized; and

16
17 WHEREAS, the Court of Common Pleas - Juvenile Division has been awarded a State
18 Fiscal Year 2020 RECLAIM Ohio grant from the Ohio Department of Youth Services, for the
19 period 7/1/19 through 6/30/20, in an estimated amount of \$4,050,428.30, with no local match
20 requirement, for the Court to target specific areas to divert youth from becoming
21 institutionalized; and

23 WHEREAS, it is necessary to appropriate said grant funds; and

25 WHEREAS, this Council finds and determines after reviewing all pertinent information
26 that it is necessary and in the best interest of the County of Summit to authorize the County
27 Executive to execute any documents necessary to accept the award of the aforementioned
28 RECLAIM Ohio grant and to appropriate said grant funds;

30 NOW THEREFORE, BE IT RESOLVED, by the Council of the County of Summit, State

35 The County Executive is hereby authorized to execute any documents necessary to accept
36 an award from the Ohio Department of Youth Services of a State Fiscal Year 2020 RECLAIM
37 Ohio grant, for the period 7/1/19 to 6/30/20, in an estimated amount of \$4,050,428.30, with no
38 local match requirement.

25 effect and be in force at the earliest time provided by law.




