7 **A Resolution confirming an award by the Board of Control of a purchase contract with**
8 **Action Target Inc., for the replacement of an indoor pneumatic shooting system for the**
9 **Sheriff's Training Facility, at GSA pricing, in an amount not to exceed \$80,380.00, for the**
10 **Sheriff, and declaring an emergency.**

12 WHEREAS, the Board of Control, at its meeting held May 29, 2019, awarded a purchase
13 contract with Action Target Inc., for the replacement of an indoor pneumatic shooting system for
14 the Sheriff's Training Facility, at GSA pricing, in an amount not to exceed \$80,380.00, subject to
15 confirmation by County Council; and

17 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
18 that the contract is necessary and in the best interest of the County of Summit;

20 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
21 of Ohio, that:

23 SECTION 1

25 The award by the Board of Control of a purchase contract with Action Target Inc., for the
26 replacement of an indoor pneumatic shooting system for the Sheriff's Training Facility, at GSA
27 pricing, in an amount not to exceed \$80,380.00, is hereby confirmed and the County Executive is
28 hereby authorized to execute such contract.

30 SECTION 2

32 This Resolution is hereby declared an emergency in the interest of the health, safety and
33 welfare of the residents of the County of Summit, and for the further reason to immediately
34 provide for the necessary replacement so that the shooting range at the Training Facility is
35 restored and fully functioning to accommodate the Sheriff's training needs.

39 Provided this Resolution receives the affirmative vote of eight members, it shall take
40 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
41 effect and be in force at the earliest time provided by law.

45 It is found and determined that all formal actions of this Council concerning and relating
46 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
47 deliberations of this Council and of any of its committees that resulted in such formal action,
48 were in meetings open to the public, in compliance with all legal requirements, including Section
49 121.22 of the Ohio Revised Code.




