7 **A Resolution authorizing the County Executive to advertise for bids for the disposal of**  
8 **sludge from the Fishcreek WWTP #25, located in the City of Stow, and the Upper Tusc**  
9 **WWTP #36, located in Springfield Township, in Council Districts 3 and 8, respectively, to a**  
10 **solid waste landfill, for an estimated total cost not to exceed \$330,000.00, for the Executive's**  
11 **Department of Sanitary Sewer Services, and declaring an emergency.**

12  
13 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit  
14 requires this Council's authorization for the County Executive to advertise for bids; and

15  
16 WHEREAS, sludge, grit and debris, generated from the wastewater treatment plants is  
17 required to be disposed in accordance with Ohio EPA regulations, and disposal at a solid waste  
18 landfill meets those regulations; and

19  
20 WHEREAS, the County Executive wishes to advertise for bids for the disposal of sludge  
21 from both the Fishcreek WWTP #25, located in the City of Stow, and the Upper Tusc WWTP  
22 #36, located in the Springfield Township, in Council Districts 3 and 8, respectively, to a solid  
23 waste landfill, for an estimated total cost not to exceed \$330,000.00; and

25 WHEREAS, a copy of the bid specifications is on file in the Clerk of Council's office;

28 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
29 that it is necessary, and in the best interest of the County of Summit to authorize the County  
30 Executive to advertise for bids for the aforementioned disposal of sludge;

32 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
33 of Ohio, that:

35 SECTION 1

37 The County Executive is hereby authorized to advertise for bids for the disposal of sludge  
38 from both the Fishcreek WWTP #25, located in the City of Stow, and the Upper Tusc WWTP  
39 #36, located Springfield Township, in Council Districts 3 and 8, respectively, to a solid waste  
40 landfill, for an estimated total cost not to exceed \$330,000.00.

42 SECTION 2

44 This Resolution is declared an emergency in the interest of the health, safety and welfare  
45 of the residents of the County of Summit, and for the further reason that it authorizes the  
46 Executive to immediately advertise for the aforementioned disposal of sludge from the WWTP's  
47 so that the Plants can maintain compliance with Ohio EPA requirements.
