7 **A Resolution authorizing the County Executive to execute an agreement with Patricia M.**
8 **Knotts in the amount of \$400.00, to acquire an easement over her real property located at**
9 **677 E. Turkeyfoot Lake Road, Akron, Ohio 44319, and known as Permanent Parcel No.**
10 **2805397, as part of the E. Turkeyfoot Lake Rd. Sewer Project (Q-967), located in the City**
11 **of Green, in Council District 8, for the Executive's Department of Sanitary Sewer Services,**
12 **and declaring an emergency.**

14 WHEREAS, sanitary sewer easements are needed for the E. Turkeyfoot Lake Rd. Sewer
15 Project (Q-967) ("Project"), located in the City of Macedonia, in Council District 1; and

17 WHEREAS, the County Executive desires to execute an agreement with Patricia M.
18 Knotts, in the amount of \$400.00, to acquire an easement over her real property located at 677 E.
19 Turkeyfoot Lake Road, Akron, Ohio 44319 and known as Permanent Parcel No. 2805397, as
20 part of the Project; and

22 WHEREAS, the procurement of the easement is necessary to help facilitate the
23 completion of the Project, which will promote development along the Turkeyfoot Lake Rd.
24 corridor and extend service to the city owned park; and

26 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
27 that it is in the best interest of the County of Summit to authorize the County Executive to
28 execute an agreement with Patricia M. Knotts, in the amount of \$400.00, to acquire the
29 aforementioned easement as part of the Project;

31 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
32 of Ohio, that;

36 The County Executive is hereby authorized to execute an agreement with Patricia M.
37 Knotts, in the amount of \$400.00, to acquire an easement over her real property located at 677 E.
38 Turkeyfoot Lake Road, Akron, Ohio 44319 and known as Permanent Parcel No. 2805397, in the
39 City of Green, in Council District 8, as part of the E. Turkeyfoot Lake Rd. Sewer Project (Q-967)
40 ("Project"), and to accept said easement for the County of Summit.

44 This Resolution is hereby declared an emergency in the interest of the health, safety and
45 welfare of the residents of the County of Summit and for the purpose of allowing construction of
46 the Project to proceed immediately.
