7 **A Resolution authorizing the County Executive to execute a settlement agreement and**
8 **release, in an amount not to exceed \$3,500.00, to settle all claims arising out of or**
9 **concerning issues raised in a Workers' Compensation Claim No. 17-124985 brought by**
10 **Vickie Mullaly, for the Executive and the Summit Developmental Disabilities Board, and**
11 **declaring an emergency.**

13 WHEREAS, Vickie Mullaly, an employee of the Summit Developmental Disabilities
14 Board, filed a Workers' Compensation claim, Claim No. 17-124985 (the "Claim") with Ohio
15 Bureau of Workers' Compensation; and

16
17 WHEREAS, in consultation with the County Prosecutor, the County Executive has
18 reached terms of settlement with Ms. Mullaly, by and through her legal counsel, to settle the
19 Claim for an amount not to exceed \$3,500.00; and

20
21 WHEREAS, pursuant to the settlement agreement and release, Ms. Mullaly will settle
22 and close the Claim; dismiss all related Workers' Compensation claims and release and
23 discharge the County of Summit and the Ohio Bureau of Workers' Compensation from her
24 claims against them; and

26 WHEREAS, pursuant to the settlement agreement and release, the County will pay Ms.
27 Mullaly an amount not to exceed \$3,500.00 from its Workers' Compensation funds; and

29 WHEREAS, this Council finds and determines, after reviewing all pertinent
30 information, that it is necessary and in the best interest of the County of Summit to settle the
31 Claim for an amount not to exceed \$3,500.00, for the aforementioned reason;

33 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
34 of Ohio, that:

38 The County Executive is hereby authorized to execute a settlement agreement and release
39 in an amount not to exceed \$3,500.00, to settle all claims arising out of or concerning issues
40 raised in Workers' Compensation Claim No. 17-124985 brought by Vickie Mullaly, (the
41 "Claim") and all related Workers' Compensation claims. The settlement agreement shall include
42 a release and discharge by Ms. Mullaly of all claims against the County of Summit and the Ohio
43 Bureau of Workers' Compensation.

6 This Resolution is hereby declared an emergency in the interest of the health, safety and
7 welfare of the residents of the County of Summit and for the further purpose of immediately
8 sparing county taxpayers further expense related to Ms. Mullaly's Workers' Compensation claim
9 and related Worker's Compensation claims against the County of Summit and the Ohio Bureau
10 of Workers' Compensation.

14 Provided this Resolution receives the affirmative vote of eight members, it shall take
15 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
16 effect and be in force at the earliest time provided by law.

20 It is found and determined that all formal actions of this Council concerning and relating
21 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
22 deliberations of this Council and of any of its committees that resulted in such formal action,

24 121.22 of the Ohio Revised Code.
