7 **A Resolution confirming an award by the Board of Control of a renewal (first of two) of**
8 **professional service contracts between certain providers and the County's Department of**
9 **Job and Family Services and the Summit and Medina Workforce Area Council of**
10 **Governments, to provide in-school and out-of-school youth employment and educational**
11 **services under the Comprehensive Case Management and Employment Program, for the**
12 **period 7/1/19 to 6/30/20, in a total amount not to exceed \$2,225,000.00, for the Executive's**
13 **Department of Job and Family Services, and declaring an emergency.**

15 WHEREAS, the Board of Control, at its meeting held May 8, 2019, awarded a renewal
16 (first of two) of professional service contracts between certain providers and the County's
17 Department of Job and Family Services and the Summit and Medina Workforce Area Council of
18 Governments to provide in-school and out-of-school youth employment and educational services
19 under the Comprehensive Case Management and Employment Program, for the period 7/1/19 to
20 6/30/20, in a total amount not to exceed \$2,225,000.00, as more fully set forth on Exhibit A,
21 attached hereto and incorporated herein by reference, subject to confirmation by County Council;

24 WHEREAS, as required by the Comprehensive Case Management and Employment
25 Program, said professional service contracts will be funded by both Workforce Innovation and
26 Opportunity Act funding through the Summit and Medina Workforce Area Council of
27 Governments and Temporary Assistance to Needy Families funding through the County's
28 Department of Job and Family Services; and

30 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
31 that it is necessary and in the best interest of the County to enter into the aforementioned
32 professional service contracts;

34 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

39 The award by the Board of Control a renewal (first of two) of professional service
40 contracts between certain providers and the County's Department of Job and Family Services

43 Management and Employment Program, for the period 7/1/19 to 6/30/20, in a total amount not to
44 exceed \$2,225,000.00, as more fully set forth on Exhibit A, attached hereto and incorporated
45 herein by reference, is hereby confirmed and the County Executive is hereby authorized to
46 execute said contracts.

8 effect and be in force at the earliest time provided by law.



16 121.22 of the Ohio Revised Code.


