7 **An Ordinance amending Section 113.03 of the Codified Ordinances of the County of**
8 **Summit, entitled "Criminal Background Checks, Fingerprinting Fee, and Sex Offender**
9 **Registration Fee," to increase fees for BCI and FBI processing, for the Sheriff, and**
10 **declaring an emergency.**

11
12 WHEREAS, upon a review of the current fees for the County Sheriff for BCI and FBI
13 background checks, it is necessary to increase those fees to be comparable with other counties
14 in the State of Ohio; and

15
16 WHEREAS, this Council has determined, after reviewing all pertinent information, that
17 it is necessary and in the best interest of the County of Summit to amend Section 113.03 of the
18 Codified Ordinances of the County of Summit, entitled "Criminal Background Checks,
19 Fingerprinting Fee, and Sex Offender Registration Fee," to increase the aforementioned fees;

21 NOW, THEREFORE BE IT ORDAINED by this Council of the County of Summit,
22 State of Ohio, that:

24 SECTION 1

25
26 Section 113.03 of the Codified Ordinances of the County of Summit, entitled "Criminal
27 Background Checks, Fingerprinting Fee, and Sex Offender Registration Fee," is hereby
28 amended as follows:

30 **"113.03 CRIMINAL BACKGROUND CHECKS, FINGERPRINTING FEE, AND**
31 **SEX OFFENDER REGISTRATION FEE.**

33 (a) The County Sheriff, when required to provide criminal background
34 checks and/or fingerprinting for any person, business, firm, agency or governmental
35 body, shall charge the following fees:

37 Nongovernmental \$10.00
38 Governmental (Non law enforcement) 2.00
39 Governmental (Law enforcement) No fee

41 (b) BCI Web Check Fees.

43 Electronic Transmission Service \$15.00
44 BCI processing fee ~~\$30.00~~ \$33.00
45 FBI processing fee ~~\$30.00~~ \$33.00

47 (c) Sex Offender Registration Fee.

48
49 The Summit County Sheriff shall follow the fee schedule and rules set by the
50 Ohio Revised Code, Section 311.171, as amended, for Sex Offender Registration costs.

6 The Sex Offender Registration Fees shall be as follows:

8 Annual registration under ORC 2950.04 or 2950.04 \$25.00
9 Registration of a new residence address under ORC 2950.05 \$25.00
10 Registration to verify a current residence address under ORC 2950.06 \$25.00"

12 SECTION 2

13
14 This Ordinance is hereby declared an emergency in the interest of the health, safety, and
15 welfare of the residents of the County of Summit, and for the further purpose of immediately
16 increasing fees for BCI and FBI processing for the County Sheriff.

18 SECTION 3

19
20 Provided this Ordinance receives the affirmative vote of eight members, it shall take
21 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
22 effect and be in force at the earliest time provided by law.

24 SECTION 4

25
26 It is found and determined that all formal actions of this Council concerning and
27 relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and
28 that all deliberations of this Council and of any of its committees that resulted in such formal
29 action, were in meetings open to the public, in compliance with all legal requirements,
30 including Section 121.22 of the Ohio Revised Code.
