7 **A Resolution authorizing the County Executive to execute any documents necessary to**
8 **accept an award from the Ohio Department of Public Safety's Office of Criminal Justice**
9 **Services of a Drug Law Enforcement Fund grant, in the amount of \$52,110.34, with a 25%**
10 **local cash match requirement of \$17,370.12, for the period 1/1/19 through 12/31/19, and**
11 **appropriating \$69,480.46, for the Sheriff, and declaring an emergency.**

13 WHEREAS, the Ohio Department of Public Safety's Office of Criminal Justice Services,
14 ("ODPS-OCJS") has awarded the Sheriff's Office a Drug Law Enforcement Fund ("DLEF")
15 grant in the amount of \$52,110.34, with a 25% local cash match requirement of \$17,370.12, for
16 the period 1/1/19 through 12/31/19; and

18 WHEREAS, this DLEF grant will fund a countywide drug unit task force which will
19 specifically target the manufacture, distribution and acquisition of illegal drugs in Summit
20 County; and

22 WHEREAS, the local cash match will be provided by funds from the Sheriff's Summit
23 County Drug Unit checking account; and

25 WHEREAS, this Council has determined by reviewing all pertinent information that it is
26 necessary and in the best interest of the County of Summit to authorize the Executive to execute
27 any documents necessary to accept the award of the aforementioned DLEF grant from the
28 ODPS-OCJS, and to appropriate said grant funds;

30 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
31 of Ohio, that:

35 The County Executive is hereby authorized to execute any documents necessary to accept
36 an award by the Ohio Department of Public Safety's Office of Criminal Justice Services
37 ("ODPS-OCJS") of a Drug Law Enforcement Fund ("DLEF") grant in the amount of
38 \$52,110.34, with a 25% local cash match requirement of \$17,370.12, for the period 1/1/19
39 through 12/31/19.

15 the DLEF grant funds from ODPS-OCJS to be used by the countywide drug unit task force to
16 address the problem of illegal drugs in Summit County.

21 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
22 effect and be in force at the earliest time provided by law.
