7 **A Resolution authorizing the County Executive to execute an agreement with Adam J. and**  
8 **Crystal D. Price in the amount of \$2,830.00, to acquire an easement over their real**  
9 **property located at 8615 North Bedford Rd., Macedonia, Ohio 44056, and known as**  
10 **Permanent Parcel No. 3300915, as part of the Indian Creek Exposed Sewers Project (Q-**  
11 **180), located in the City of Macedonia, in Council District 1, for the Executive's**  
12 **Department of Sanitary Sewer Services, and declaring an emergency.**

13  
14 WHEREAS, sanitary sewer easements are needed for the Indian Creek Exposed Sewers  
15 Project (Q-180) ("Project"), located in the City of Macedonia, in Council District 1; and

16  
17 WHEREAS, the County Executive desires to execute an agreement with Adam J. and  
18 Crystal D. Price, in the amount of \$2,830.00, to acquire an easement over their real property  
19 located at 8615 North Bedford Rd., Macedonia, Ohio 44056 and known as Permanent Parcel No.  
20 3300915, as part of the Project; and

22 WHEREAS, the procurement of the easement is necessary to help facilitate the  
23 completion of the Project, which will allow the County to eliminate the exposed sanitary sewer  
24 lines crossing Indian Creek; and

26 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
27 that it is in the best interest of the County of Summit to authorize the County Executive to  
28 execute an agreement with Adam J. and Crystal D. Price, in the amount of \$2,830.00, to acquire  
29 the aforementioned easement as part of the Project;

31 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
32 of Ohio, that;

36 The County Executive is hereby authorized to execute an agreement with Adam J. and  
37 Crystal D. Price, in the amount of \$2,830.00, to acquire an easement over their real property  
38 located at 8615 North Bedford Rd., and known as Permanent Parcel No. 3300915, in the City of  
39 Macedonia, in Council District 1, as part of the Indian Creek Exposed Sewers Project (Q-180)  
40 ("Project"), and to accept said easement for the County of Summit.

44 This Resolution is hereby declared an emergency in the interest of the health, safety and  
45 welfare of the residents of the County of Summit and for the purpose of allowing construction of  
46 the Project to proceed immediately.


